


Since 1958, LAM has helped low-income Marin County residents address critical legal issues directly affecting their homes, incomes, jobs and families. Our work protects and serves Marin's most vulnerable residents by providing access to legal justice. We create economic and social impacts that help make Marin County a better place for everyone.

EXECUTIVE DIRECTOR'S REPORT

The Year in Review

LAM is poised for another great year in 2015. We have 57 years of service to Marin in the books and we are constantly finding new ways to serve our clients and those hungry for legal education. The difference that we make both by teaching people their rights and exercising those rights can be mind-boggling. We positively impact individuals and families every day we are on the job.

In 2014, we settled a class action lawsuit impacting hundreds of low-income residents, we assisted employees to recapture wages and we helped families navigate the family court system. Over 2,000 households were served.

We know that for every \$1,000 spent on free legal services for Marin residents, the community receives a minimum financial benefit of \$7,000. LAM is a positive return on any donor investment.

We established new office hours in Marin City, we have a staff person coordinating the Marin Community Court, we hired a Director of Communications & Development and we leveraged volunteer contributions valued at more than \$2.5 million.

2015 promises to bring even more impact for the whole community as we establish the new State Bar certified Marin Lawyer Referral Service ("MLRS") so that every Marin resident can have guidance to identify an attorney that can help them in any legal matter. This will be the first time LAM is providing a service accessible to the whole community.

MARIN COMMUNITY COURT

Three Years of Success

The award-winning Marin Community Court continues to be the last bastion of hope for some of the most vulnerable members of our community. It started in 2011 as a collaborative project between LAM, the Marin Superior Court and the St. Vincent de Paul Society of Marin County to help the homeless and those at risk of homelessness to clear up citations, **turn lives around and get people back on their feet**. The number of volunteers, participants and pro bono attorneys continues to grow–allowing the special court to blossom into a trusted and valued institution of its own.

2,985 hours of community service completed by 114 participants

UNCLOGGING THE COURT SYSTEM

10 court sessions 322 appearances 235 tickets zeroed out \$125,000 saved by participants

SOCIAL IMPACT

29 participants completed alternative sentence (sobriety programs, mental health care, veteran services, etc). ELDER LAW

Empowering Older Adults

To understand the difference LAM can make protecting the legal rights of Marin's older adults, consider the story of Audrey McNamara Nevis.

As a pioneering flight attendant with Trans World Airlines, Audrey dedicated her life to serving and helping others. When she reached retirement, however, her trust was abused by predatory lenders. Her Lucas Valley home was refinanced 15 times. Without any family and facing homelessness at age 81, Audrey, pictured at right throughout her life, came to LAM for help.

LAM helped reach a settlement that secured housing for the remainder of Audrey's life, restoring dignity and respect at a time when she needed it most.

OLDER ADULT LAW IMPACT

30% of all LAM clients are 60 or older

18.9% of Marin residents are 65 or older –the fastest growing population in our county.

LAM provides nearly **2,000 hours** of legal service to older adults each year helping them deal with elder abuse – physical, emotional or financial.



EMPLOYMENT LAW

Protecting Low-Wage Workers

LAM's employment law team represents Marin's workers in claims of wage theft, employment discrimination and wrongful termination. We give a full scope of representation for clients who could not otherwise afford an attorney, including low-wage janitorial, domestic and restaurant workers. Since 2012, LAM has partnered with the firms of Chavez & Gertler, Goldstein, Borgen, Dardarian & Ho, and the Stanford Community Law Clinic on litigating a proposed class action suit against against the corporation that operates Ross Dress For Less, as well its prime contractor USM, Inc. Led by LAM's Joanna Shalleck-Klein, nearly two years of litigation uncovered an elaborate subcontracting scheme showing how Ross and USM systematically underpaid **hundreds of janitors throughout California**. The case, *Vasquez, et al v. USM*, *Inc., et al.*, is still active.

EMPLOYMENT LAW IMPACT

HOUSING LAW

Keeping Marin's Most Vulnerable Citizens in their Homes

Healthier homes, affordable housing, eviction prevention and access to code enforcement continue to be a big focus of LAM's advocacy work. In July, in cocounsel with the San Francisco firm of Sommers and Schwartz, LAM settled a case with the Marin Housing Authority over misallocated rent payments, fees and violations relating to eviction and grievance procedures. After two long years of litigation, more than **1,000 incorrect transactions were refunded** to over **500 Marin tenants** – including Ariana Martinez (above), who was able to stay on track to reach her goal of becoming a physician's assistant.

FAMILY LAW

Representing Families in Our Community

Among the multiple hundreds of cases that pass through LAM's office each year, the most contentious can be in the emotional area of family law. Divorce, custody disputes, paternity cases, restraining orders- these issues can overwhelm a client with a feeling of helplessness and despair. "A mother came to LAM recently and said she wanted to 'just give up' because she was so intimidated by the family court system," said LAM Staff Attorney Laurie Joyce. "After we assisted her to get the custody results she hoped for, she was so thankful. She had her first good night of sleep in a long time, and said she finally felt her children were safe."

IRMA V. put her life on the line to extinguish a fire ignited in a neighbor's unit at her apartment complex. After incurring medical expenses to treat her injuries, she asked the landlord for help.

When the landlord stonewalled, LAM Staff Attorneys Maura Prendiville and Araceli Ontiveros-Venegas helped Irma file a small claims action against the landlord. The response was immediate. The landlord paid all of the client's medical expenses and the issue was settled out of court.



Above and Beyond

Some cases can be too complex to fit into one particular program. To ensure that these cases do not fall between the cracks, LAM staffers often go above and beyond their areas of specialty.



LOVELY NAKOOKA suffered a childhood of neglect and abuse in foster care, ending up homeless at age 17. After 8 years on the Section 8 voucher waiting list, a pregnant Lovely came to LAM for help.

LAM successfully appealed for her eligibility, securing housing benefits for Lovely just in time for the arrival of her newborn son. To celebrate, Senior Staff Attorney Maura Prendiville coordinated a baby shower in LAM's offices, providing Lovely with baby toys and much-needed supplies.

VOLUNTEERS AND PRO BONO ATTORNEYS

Making a difference for the public good

LAM has a growing network of pro bono attorneys and community volunteers that has been a part of the organization since it was founded in 1958.

LAM's pro bono program is managed by Nancy Murphy, who for the past 28 years has partnered with hundreds of attorneys and dozens of law firms from Santa Rosa to Silicon Valley, helping an average of 500 clients each year. "We are able to help a lot of people, even if only a little bit," said Murphy.




